**SUBJECT:** Grants and Contracts - Provider

### **Item Description**

This item requests that the Board approve the receipt of funding for the listed projects.

## Overview and Background

The following are recommended for approval:

# I. Receipt, Amendment, Extension of Resources

Leon County - Leon County Tourism Development Sports Event Grant

This award provides support for the Seal Financial Tipoff Classic Basketball event. The amount of this award is \$750, with an indirect cost rate of 0%.

Leon County - Leon County Tourism Development Sports Event Grant

This award provides support for the Holiday Classic Basketball event. The amount of this award is \$1,000, with an indirect cost rate of 0%

Leon County - Leon County Tourism Development Sports Event Grant

This award provides support for the Capital Courtyard Classic Basketball. The amount of this award is \$1,499, with an indirect cost rate of 0%.

Florida Department of Education - Troops to Teachers, Initial award and Amendment 1

This award provides the coordination of post-secondary education for current military personnel and veterans, specifically guiding those interested in pursuing teacher certifications in Florida. This program will expand online courses and increase the College's capacity to serve veterans. The related amendment corrects the indirect cost calculation. This is a multi-year award, and this initial year is \$346,927, with an indirect cost rate of 8%. The funding period is from 07/01/2018 through 05/31/2019.

## Office of the Florida Attorney General – Victims of Crime Act (VOCA) Grant

This award provides support for a victim's advocate position. The college has a required cash match of 25%, which amounts to \$11,875 for a twelve-month period. The amount of this award is \$59,377, with an indirect cost rate of 0%. The grant period is through 9/30/19.

US Department of Education - Gadsden County Talent Search Program

This award is for the 3<sup>nd</sup> year of a 5-year award, Talent Search identifies and assists students in middle and high school from disadvantaged backgrounds in Gadsden County who have the potential to succeed in higher education. It provides academic, career, and financial counseling to its participants and encourages them to graduate from high school and continue on to and complete their postsecondary education. The amount of this award is \$256,455, including an indirect cost rate of 5%. The funding period is from 9/1/2018 through 8/31/19.

US Department of Labor - Mine Safety Award Amendment

This amendment is a no cost extension through 9/30/19.

## Past Actions by the Board

<u>US Department of Labor – Mine Safety Award</u> - initially approved at the August Board meeting.

<u>US Department of Education – Gadsden County Talent Search Program – annual continuation of program last approved at the September 2017 Board meeting.</u>

# Funding/Financial Implications

The above projects are established in Fund 2, Restricted Accounts. The indirect earned from the above award and amendments is \$46,005.
