# **Course Information**

The student must be a Florida law enforcement officer and,

The student must have successfully completed the Speed Measurement Instructor Course (SMI) - 1159 (or one of the retired FDLE Courses), and

The student must have an ACTIVE SMI Certification in FDLE ATMS ,

The student must have an ACTIVE FDLE General Instructors Certification.

This class is 8 hours and is **NOT** a salary incentive course. Training Authorization forms must be signed by agency representative authorizing the training.

## WHAT SHOULD I BRING?

It is suggested that a vehicle equipped with a radar and a laser unit from your agency is brought with you to the training as well as a computer to create the classroom presentation.

All other materials will be provided by FPSI.

## WHAT ARE THE EXPENSES TO ATTEND?

Tuition for FDOT grant funded classes is covered fully by the grant. Housing and meals are covered **ONLY** for classes held at the Florida Public Safety Institute where the student is traveling over 50 miles to attend.
